### REPORT OF THE CONGREGATION COUNCIL PRESIDENT

As I write this, the most significant topic which comes to mind for me is transition. By definition, transition is a process or period of changing from one state or condition to another; to undergo a process. Some transitions are easy, some are challenging. I will not attempt to qualify our transition here at Good Shepherd, other than suggesting it is huge and the largest we have had in quite some time. While I was not here at the time, as some of you were, Lutheran Church of the Good Shepherd was born of a transition. The combining of Advent and St. Mark's under the leadership of Pastor Schneider was the first transition. When Pastor Schneider left, Pastor Spice was soon joined by Pastor Russell and we experienced our next transition. We were stable for almost 30 years with Pastor Russell.

My mini-history lesson is to reinforce the definition of transition, in that we are changing from one state (pastor) to another pastor. Fortunately, the Synod provided us with an experienced, highly effective interim pastor. Pastor Kurt Strause has been working with Council and the Transition Team getting to know us and leading us through the call process so that we ultimately end our current transition with a new, permanent pastor.

As we prayerfully work through our pastor transition, I must be fully transparent on another topic – the budget. While certainly there is no need for an uncontrolled knee-jerk reaction now, there is a need for you to know we are facing challenges. In preparation for today, at a recent meeting, Council engaged in a lengthy and detailed discussion of the financial health of Good Shepherd. All facets of the budget were discussed, including expenditures and revenues. A large portion of our budget contains fixed expenses such as mortgage, salaries, utilities, and insurances. Consequently, we have limited areas to review for possible modification, but even so, we are starting to do just that. Through the Finance Committee, we are looking to develop options and programs which will address expenditures as well as giving opportunities (revenues).

To borrow a few words from our Stewardship Chairperson, Dennis Zimmerman, "God has plans. God needs us to make them happen." The small groups, music program, creation care, Grace meal, landscaping, child safety, etc., are a manifestation of God's plans and ideas for the benefit of ourselves and others. (Please read the individual reports for more information.) We need one another always and especially now during this transition. Let us stay strong and generous to grow together.

### REPORT OF THE PASTOR

Arriving to serve as your Interim Pastor just a little over two months ago doesn't allow me much time to experience the fullness of a year's life in your congregation. I've been a pastor long enough to know that you can only really know a church when you've journeyed with them through a full cycle of the church's calendar: Advent, Christmas, Epiphany, Lent, Easter, Pentecost. There are other rhythms to our life as well, the change of seasons, school year, vacations, etc. I also know Good Shepherd has experienced significant transitions over the past few years; the covid-induced shut-down (and subsequent "slow-down"), Pastor Russell's retirement after almost thirty years of faithful service, and a significant 50th anniversary celebration.

Still, two months with you has given me some rather strong impressions. These come from conversations with leaders and staff, interviews conducted during a series of "cottage meetings," and leading worship and educational events. In no particular order I offer these observations and impressions:

- A well-ordered, intentionally Lutheran, and artistically conducted liturgy is central to Good Shepherd's life.
- A core of active persons, both lay volunteers and staff, are providing committed leadership during a significant time of transition.
- There is a heart for service to the community manifest especially in feeding ministries.
- Good Shepherd takes seriously its impact on the environment and God's creation.
- You are continuing to live into what a "post-covid pandemic" reality might look like which includes the changing ways people participate in the life of the congregation.
- Many in the congregation are aware of your Vision Statement to live "out the unconditional love and radical hospitality of Jesus" and apply it to ministry in the church and daily life.
- There is eagerness to move forward under the guidance of the Holy Spirit in seeking new pastoral leadership. There is not a lot of anxiety about the process.

Thank you for the very warm welcome you have extended to me, and my wife Lois. I am looking forward to continuing to work with you as you seek to serve the Lord and be faithful servants in the community.

### OVERVIEW

Preparing for the 2024 ministry of Good Shepherd is challenging and exciting as we contemplate the possibilities during the next calendar year. Changes in pastoral staff and evolution of our congregation's mission will undoubtedly reshape our ministries. This budget includes continued support for the ministries defined by this congregation's Council and volunteers to express our faith locally and beyond. An overview of that plan appears below, highlighting changes as compared to last year's plan.

**ESSENTIAL FINANCIAL INFORMATION** – The proposed 2024 LCGS Operating Budget totals approximately \$502,000, which represents a decrease of 3.1% over the 2023 budget. In framing a budget plan, the Congregation Council always attempts to balance two concerns: the desire to provide funding essential to continue the program life of our congregation and the need to be responsible while constructing a budget that considers anticipated levels of financial support.

GIVING TRENDS – Good Shepherd is fortunate to have generous financial support from dedicated families sharing God's financial gifts to sustain ministries here – thank you! The Finance Committee continues to monitor giving trends and inform the Council. Our income in 2023 is behind what we received in 2022 through September creating a negative impact to the church's balance sheet. We will continue to keep the congregation informed of any concerns, but in the short term we do have modest reserve funds to meet immediate shortfalls. The present situation makes 2024 stewardship commitments important as we plan for the practical financial health of Good Shepherd. Please discern your support with prayer and extra consideration for our ministry needs as you pledge in the coming weeks.

IMPLICATIONS FOR CONGREGATIONAL LIFE – The mission plan we are presenting for 2024 continues to provide support for ministries and programs vital to our health and growth. The church council invites your input at any time to call attention to areas where we can demonstrate our commitment to - live out the unconditional love and radical hospitality of Jesus in our worship, in our service to the world, and in our shared life – even more! We continue to be open to the new things God may be calling us to as we move forward.

### I. OUR MINISTRY IN THE COMMUNITY AND THROUGH THE WIDER CHURCH

We continue to support the Lower Susquehanna Synod and other partner agencies and institutions to serve our neighbors near and far. This category also includes support to the Synod's Hunger Appeal and the Lancaster County Food Hub (formerly Lancaster Council of Churches Food Bank) – the congregation's designated gifts to support food bank causes continues to cover LCGS's respective pledges to these efforts. Our support of benevolent ministries approximates a tithe, as it is 10.7% of the Operating Budget.

The decrease in this section is related to allocations for assisting/substitute musicians and altar supplies to align with actual expenses. Budget amounts were adjusted to be in line with actual costs full-year 2020-2022, year-to-date 2023. This category does include a cost of living adjustment for the Cantor and subsequent medial insurance premium increases for the upcoming year.

### III. OUR PROGRAM MINISTRY

The decrease in this section is primarily due to the interim Pastor's medical coverage. This individual is covered by Medicare thus reducing the congregation's insurance liability in 2024. This situation will possibly change based on the call process progression/completion. \$7,500 is allocated in the current budget if the call process is completed within 2024 and full medical coverage needs to resume at the congregation's expense.

### V. PARISH ADMINISTRATIVE EXPENSES

We continue to provide resources and programming to our children, youth, and families, at a rate that compliments current youth served and program requests. This item is also supported by a continuing fund, current balance \$5,214.94, that defrays cost to attend the ELCA youth gathering. The next gathering is July 16-20, 2024, in New Orleans, LA. Additionally, there is \$1,000 available in a fund for Good Shepherd Family Fun activities.

### VII. BUILDING MAINTENANCE, UTILITIES AND INSURANCE

### REPORT OF THE RENEWAL TEAM

In January 2020, the Renewal Team, Version 2, was formed to continue the contemplation and reflection started by the our first Renewal Team of how does LCGS live out unconditional love and radical hospitality. Since then, our LCGS Family has gone through several major dynamics including COVID and two pastoral transitions. We have reflected and recognized that we are not the same as who we were in 2020 and in prior years. We have contemplated how Renewal is linked to the engagement of the people who are in our LCGS Family and not necessarily to the quantitative number of people in the pews on a Sunday morning or Wednesday evening.

Over the past years, we have also seen the formation and growth of Small Groups including Creation Care and Racial Justice. These Groups are reverent, relevant, and real in their learning, ministry, and outreach. They have allowed LCGS members a space to learn together and to live out discipleship. When the Renewal Team reached out to congregational members through surveys and conversations on possible ministry projects for our congregation, feedback including about feeding our neighbors and community and hence the establishment of a new Feeding Ministry Small Group. Through discernment, our Renewal Team has felt that by supporting our Small Groups, that we support the work of Renewal and engagement of our LCGS Family.

Our goal has always been to share our updates with LCGS, even when our work was prayer and discernment. We now want to present for our Renewal Team to transition our name and responsibility to Small Group Support. Our role may include sharing the Small Group Startup Kit, assisting Small Groups on new member advertisement and congregational communication, praying for the Small Group, and more. We still want to support LCGS as we undergo a new transition of calling a pastor. We believe the time and reflection of the Renewal Team from our past years could assist with contributions towards the Ministry Site Profile, work of the Transition Team, and all of us as we are involved in the call process. We also realize a new pastor will be a new and exciting period for LCGS, including the possibility of how a Renewal Team, Version 3, may be warranted to assess how LCGS lives out unconditional love and radical hospitality in this new chapter.

We plan on hosting an informational session in early 2024 about our wrap-up as the Renewal Team and role of Small Group Support Team. As we transition to the Small Group Support Team, we continue to be in prayer for our whole LCGS Family. We also welcome ideas and suggestions for how we support Small Groups and ideas for new Small Groups. Please also reach out to any of the below members with questions or thoughts.

### SMALL GROUP MINISTRIES OF GOOD SHEPHERD

Our small group ministry structure is unique, and provides opportunities for participants in small groups to grow in relationship, grow in faith, and, guided by the Holy Spirit, to serve together around a shared vision and mission.

I assumed the position of Small Group Coordinator upon Pastor Carla's departure from Good Shepherd in February 2022. At that time there were three small groups that were newly formed: Richard Rohr, Creation Care, and Towards Racial Justice. Currently there are six small groups including: Creation Care, Towards Racial Justice, Growing in Christ, Feeding Ministry, Knitting Together, and the Monday Bible Study small group under the leadership of Pastor Herb Lohr. More than 40 people are involved in one or more small groups, and new small groups are being explored.

There is much to be celebrated with regard to the Good Shepherd Small Group Ministry. I have attempted to list many of the activities that have taken place, and I'm certain there are more that I've not listed.

Please consider joining one of the small groups. Participation is flexible, and leadership is shared. Come and offer your talents, get to know some new people, and join in this very important ministry as we seek to "live out the unconditional love of Jesus in our Service and our Shared Life."

Here's a list of the many meaningful ways these small groups are making a difference:

### Did you know...?

- a. A "Small Group Startup Kit" is provided to all small groups outlining best practices for creating small groups that provide a place for group members of all ages to grow in faith and relationship with one another while engaging in a shared missional focus that members care deeply about.
- b. Currently, LCGS small groups involve more than 40 members from Good Shepherd, along with a few non-members.
- c. Our small groups are affiliated with two interfaith partnerships: POWER Interfaith and Interfaith Partners of the Chesapeake (IPC).
- d. The Towards Racial Justice small group has taught three different series of classes for Adult Education, sponsored a forum on POWER Interfaith, and conducted a "House Meeting" on October 29, 2023, to share opportunities for becoming involved in advocacy for equitable education for all, safe and affordable housing, equitable voter access, and prison bail reform.
- e. The members of the Creation Care small group have received Faithful Green Leaders' Training.
- f. The members of the Towards Racial Justice small group have participated in the online training *Intro to Power, Privilege, and Leadership,* and have engaged in continuous study to help us to understand and explore the impact of personal, institutional, organizational, and systemic racism.
- g. The Creation Care team has created educational Tables which they have displayed at Earth2Etown on Earth Day, Lancaster Water Week activities, Camp Kirchenwald, and within the congregation. They include: *Plastics uses, abuses, alternatives, Chesapeake*

- Watershed and uses of water, and Trees all that they offer us, all they do for the environment, communication.
- h. The Creation Team has made it possible for our church property to be certified as a Pollinator Garden through Lancaster Conservancy.
- i. The Richard Rohr small group has studied four of his publications and are devoted to turning their learning into action.
- j. Last October, in conjunction with Interfaith Partners and the Lower Susquehanna Synod, the Creation Care Team held a "Summit on the Susquehanna: Creation Care Collaboration," where leaders from various churches came to learn how Martin Luther's Small Catechism includes care of creation; and were given tools to establish green teams in their home churches.
- k. The Towards Racial Justice small group has a seat on the Steering Committee of POWER Lancaster? (https://powerinterfaith.org/)
- I. The Towards Racial Justice small group periodically attends worship with our friends at Brightside Baptist and picnics with our friends at Bethel AME, Lancaster.
- m. The Towards Racial Justice small group publishes monthly articles in the Good News intended to open eyes to the evils of racism and what we as people of faith can do to work "towards peace and justice in this and every place."
- n. A new small group "Feeding Ministry" has been formed. The Feeding Ministry small group has joined with those who led Turkey Box Tuesday to bring back the Community Thanksgiving Meal and worked it out so that we can serve folks in two ways this Thanksgiving!
- o. Community Thanksgiving Meal on November 21 and 23, 2023.
- p. Thanks to Helen Book, IPC and the Township, Good Shepherd has received a grant to make a rain garden next to the playground.
- q. The Towards Racial Justice small group has sponsored museum trips, walking tours, visits to black-owned businesses and the Lancaster Black-Owned Business Expo, and gatherings to support minority-owned restaurants.
- r. The Towards Racial Justice small group partnered with Zion Lutheran Church in Akron to learn together using The Racial Healing Handbook, by Anneliese Singh and are now reading and discussing Robert P. Jones' new book "The Hidden Roots of White Supremacy and the Path to a Shared American Future." All are welcome!
- s. The Creation Care team held outdoor worship opportunities at Good Shepherd in the fall of 2021 and 2022.
- t. In June 2023 the Towards Racial Justice small group participated in a day of advocacy at the PA State Capitol, meeting with legislators and their staffers to encourage the passing of a budget that helps to close the funding gap for underfunded schools in the Commonwealth. Underfunded schools disproportionately affect non-white children of diverse backgrounds.
- u. The Small Group ministries at Good Shepherd are active, engaged, and doing amazing work. Thanks be to God!
